Research shows a direct relationship between economic instability and child abuse (Smith, 2020).

In a report by The Star in 2023, Johor Women's League (Jewel) stated that the cases of child sexual exploitation, abuse, and violence are still being kept inside the closet due to the lack of public awareness. Jewel had come across many cases of family members stopping victims from lodging reports. When the predator is the father

or husband who is the family breadwinner, the mother or wife remained in denial of their husbands' wrongdoings despite complaints from their children (Visvanathan-Suresh, 2023).

Child abuse in Malaysia has deep consequences for the victims, both immediate and long-term. The immediate effects include physical injuries and emotional trauma. Many physical abuse injuries can be experienced by abused children victim ranging from bruises to fractures, for which medical intervention is required.
